WITH A VISION OF A CASA VOLUNTEER FOR EVERY CHILD WHO NEEDS ONE, THE AGENCY ASSIGNED 356 VOLUNTEERS TO 517 CASES. ACCORDING TO THE 2014 TEXAS ANNUAL REPORT AND DATA BOOK FROM THE DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES, TARRANT COUNTY HAD THE HIGHEST NUMBER OF CONFIRMED CASES OF CHILD ABUSE IN THE STATE. THE VOLUNTEERS SERVED A TOTAL OF 874 ABUSED AND NEGLECTED CHILDREN IN TARRANT COUNTY FOSTER CARE. OF THE 874 CHILDREN SERVED, OVER HALF (52%) WERE UNDER THE AGE OF FIVE, AND THEY REPRESENTED EVERY RACE, ETHNICITY, AND SOCIOECONOMIC STATUS. THE 356 CASA VOLUNTEERS SPENT AN AVERAGE OF 16.7 MONTHS ON A CASE, DEMONSTRATING THEIR COMMITMENT TO CHILDREN IN CRISIS.
